## Types of Membership and Fees

---

ECHO currently offers four types of membership\*

(\*Dues are half price if you join in June or later.)

1. **Single Membership:** dues are \$20 per calendar year.
    - Open to 18 years of age and older.
  2. **Family/Household Membership:** dues are \$30 per calendar year.
    - Open to any members of the same household/address.
  3. **Junior Membership:** dues are \$10 per calendar year.
    - Open to any individual who is under eighteen years of age.
  4. **Lifetime Membership – ECHO Club ONLY** - for those who have been members for 15 consecutive years.
- St Joe Valley Agility Club membership is an additional \$5 per calendar year. (No lifetime membership for SJVAC.)
