

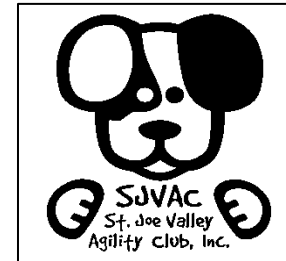

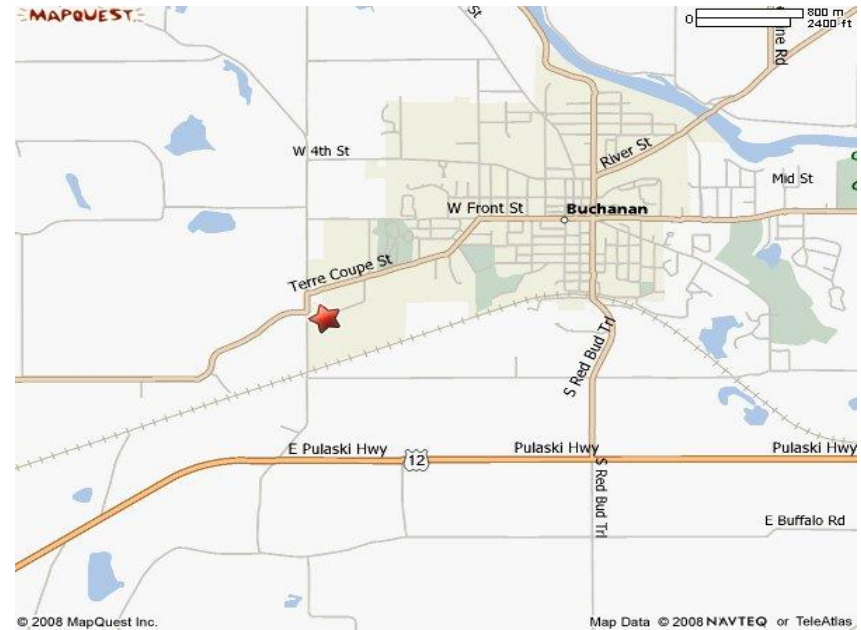

ENTRY FEES: (Includes \$3.00 for AKC Event Service fee each entry and \$0.50 recording fee on first entry)

Separate fee for each dog, each day, each trial

First entry of each dog	\$25.00
Additional entry of same dog	\$21.00

ENTRIES CLOSE WEDNESDAY, 11:59 PM February 24, 2021, unless limits are reached prior to this date. Any entries received after the published closing date or after the limits have been reached will be returned. Entry form changes, additions, corrections and cancellations MUST be received in writing or via e-mail prior to the closing of entries, and must include AKC number and breed of dog.

Please mark your dog's jump height for all classes in which jumps are used. Those classes will run in jump height order - high to low.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge or barred from competition by action of Show committee.

MAKE CHECKS and money orders payable to SJVAC, INC. (returned check charge \$20.00). All checks must have obedience class entered written on the face. THIRD PARTY CHECKS WILL NOT BE ACCEPTED. ALL ENTRIES MUST BE SUBMITTED ON OFFICIAL AKC ENTRY FORMS, one dog per entry form. Photocopies of front and back will be accepted if legible, and of official AKC size. A single entry form may be used for both days only if the information is the same for both days. To use the enclosed entry form, check the appropriate boxes for each show in which you wish to enter your dog.

ENTRIES WILL NOT BE ACCEPTED WITHOUT SIGNATURE, FEES AND BACK OF ENTRY FORM WITH AGREEMENT, nor will credit cards be accepted. All entries must be submitted with checks drawn on US Institutions or with International Money Orders in US Funds. Overnight or express mail entries must include signature permitting delivery without recipient signature.

Exhibitors should follow their Veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

NOTICE TO EXHIBITORS:

- These trials will be held in accordance with whatever COVID-19 protocols are in effect at that time.
- Due to COVID-19, it is unlikely that crating will be allowed inside the building. The decision on crating will be made closer to the trial date.
- Exhibitors must pick up after their dog(s).
- No Bitches in season in the building.
- Dogs must be at least six months old on the day of the trial.
- Show site is handicapped accessible.
- Indoor restroom facilities are available and are handicapped accessible.
- No space provided for un-entered dogs.
- No charge for parking; admission for spectators is free.
- Please turn off cell phones and/or pagers before entering the ring, and silence them when entering the building.
- The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged.
- NO entries for Irish Setters can be accepted.

Waiver of Rights

All persons attending this dog show/event, hereby waive any claim for damages against St. Joe Valley Agility Club or its member, in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.

AKC and SJVAC, Inc. are not responsible for loss, accidents or theft. Absolutely no alcoholic beverages or nonprescription drugs will be allowed on the grounds or while participating in events. AKC and SJVAC, Inc. assume no responsibility for any damage or injury sustained by the exhibitors, handlers, or to any of their dogs or property, and further assume no responsibility for injury to children not under the control of their parents or guardians.

If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fees will be made. Extreme weather conditions, such as, but not limited to, snow storms, lightning, tornadoes or extreme heat must be considered for the health and safety of the dogs, exhibitors and spectators. In the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

PRE-TRIAL MOVE UPS may be made until 6 PM EST on Monday, March 8, 2021. Day-to-day move-ups will be allowed and must be made prior to close of show on Saturday. Pre-trial move-up requests must be submitted in writing to the Trial Secretary by US mail or email. NO telephone move-ups. Move-up requests must include Owner/Handler name, name of dog, AKC Registration number, email address, class(es) entered, and move-up class(es). Move-up confirmations will be sent by email only. You must supply a valid email address to receive a confirmation. If you don't receive a reply, your move-up request was not received. The Trial Secretary is not responsible for undelivered move-up requests.

Bitches in season and bitches with an Ovarian Sparing Spay are not permitted to compete. The club will refund the entry fee, less \$10.00 processing fee, for any bitch reported to be in season no later than one half hour before the start of the trial. Any bitch excused because she is found to be "so attractive to males as to be a disturbing element" will not receive a refund.
