- This trial will be conducted in accordance with the COVID-19 protocols in effect on the trial dates.

- No indoor crating space.
- Exhibitors must pick up after their dog(s).
- No Bitches in season in the building.
- The show site is handicapped-accessible.
- Indoor restroom facilities are available and are handicapped accessible. Please be respectful of your fellow exhibitors.
- No space is provided for non-entered dogs.
- Free parking.
- Please silence cell phones and/or pagers before entering the building.
- The owner or handler of each dog is solely responsible for having it ready when it is to be judged.
- Exhibitors should follow their Veterinarians' recommendations to assure their dogs are free of internal and external parasites, and any communicable diseases and have appropriate vaccinations.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations, it includes both sexes.

Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, the dog displays no sign of physical discomfort and can safely complete the search. Deaf and blind dogs are allowed to enter. Females in season may not participate; aggressive dogs or dogs suffering from an injury or illness which may affect the dog's physical or mental performance may not participate. No dog shall compete if it is sutured, bandaged, or has any visible wounds.

STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

Staging Area will be out of view of the search area(s).

The **Handler's Briefing** will take place in view of the search area prior to the start of each class. In the Handler's Briefing, the judge will explain if there's an off-leash option, the number of hides, the maximum height of hides, and the maximum time for the search. NO DOGS are to be present during the Handler's Briefing.

A **warm-up area** will be available. Exhibitors should limit their warm-up to (2) two minutes or less. The warm-up area is to be used exclusively for warming up the handler-dog team prior to their run. The warm-up area is not for training or relieving of the dog.

SEARCH AREA AND RING CONDITIONS

Search areas may be of any shape and of the size specified in the Regulations for each class.

Search Area Conditions. Searches may be indoors, on matted, carpeted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces.

It is not appropriate to visit the trial location prior to the trial date. Many search locations are real-life environments, and such visits may risk the host losing the opportunity to use the location in the future.
