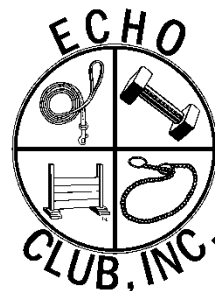

TWO DAY EVENT Four UKC Licensed Nosework Trials

Location: ECHO Club Building
457 Post Road
Buchanan, MI 49102

Restaurants nearby - less than ten minutes from show site.

Advanced Registration Deadline: September 22, 2021
Day of Show entries will be accepted unless the trial is full.

Directions to Show Site:

From West: (From New Buffalo, MI) I-94 to Exit 4A, US 12 East to Bakertown Rd. (approximately five miles east of Galien.) Turn left (north) on Bakertown.

From North, South & East: Take US 31 / 20 Bypass to Exit 3, US 12 in Michigan. Go west approximately four miles to Bakertown Rd. Turn right (north) on Bakertown.

Once on Bakertown Road, go north one mile to Post Road. The ECHO building and grounds are on the southeast corner of Bakertown and Post Roads.

Refunds:

- Participants may request a full refund before the closing date. After the closing date no refunds will be issued, except as stated in the Nosework rules in regards to judge changes or bitches in season.
- Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by a vet or judge, or barred from competition by action of show committee.

If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fees will be made. Extreme weather conditions, such as, but not limited to snow storms, lighting, tornadoes or extreme heat must be considered for the health and safety of the dogs, exhibitors and spectators. In the event it is necessary to cancel or stop the show before completion, no refunds will be made.

UKC and ECHO are not responsible for loss, accidents or theft. Absolutely no alcoholic beverages or unprescribed drugs will be allowed on the grounds, or while participating in the events, or in the building the day of a UKC Licensed Event.

UKC and ECHO assume no responsibility for any damage or injury sustained by the exhibitors, handlers, or to any of their dogs or property, and further assume no responsibility for injury to children not under the control of their parents or guardians.

Bitches in season and bitches with an Ovarian Sparing Spay are not permitted to compete. The club will refund the entry fee, less \$10.00 processing fee, for any bitch reported to be in season no later than one half hour before the start of the trial. Any bitch excused because she is found to be "so attractive to males as to be a disturbing element" will not receive a refund.

Show Entry Fees:

Element: Pre-entry \$20.00/trial, DOS \$25.00/trial
Handler Discrimination: Pre-entry \$20.00/trial, DOS \$25.00/trial

NOTE: For those with multiple dogs, exhibitors may handle only one dog per element level per trial. For example, you may run one dog in novice Containers, and another in advance Containers, but the same handler cannot run 2 dogs in novice. Entries will be returned for handlers with 2 or more dogs entered in the same element level.

This event will be held in accordance with the COVID-19 protocols in effect at the time.

Doors open both days at 8:00 a.m. Eastern (Michigan) Time.
 Day of show entries will be taken from 8:00-8:30 am.
 Trial 1 will begin at 9:00 am.

Trials are limited to 125 entries each day.

- ◆ Pre-registration is preferred and will save you money.
- ◆ There will be no setup available before the day of show.
- ◆ Confirmation emails will be sent to all pre-entered exhibitors.
- ◆ Pre-entered dogs must be checked in 30 minutes before the start of their class.
- ◆ It is your responsibility to clean up after your dog. Anyone not picking up after their dog will be asked to leave. No refunds.
- ◆ Lunch break will be determined by Judge.
- ◆ ECHO Club, Inc. reserves the right to refuse any entry.
